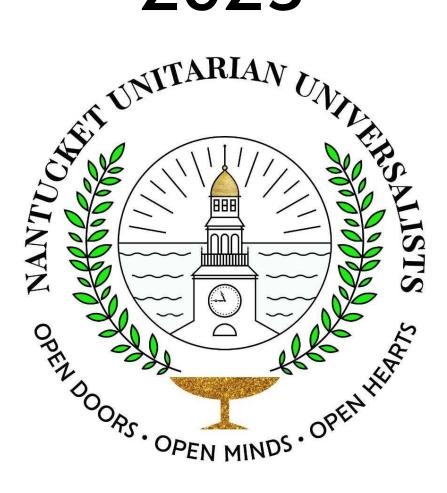

# 2023 Annual Meeting Minutes via Zoom

**Board of Trustees Present:** President Loretta Middleton, Vice-President Carl Borchert, Clerk Susan Richards, Treasurer Paul Stewart, Trustees - Kathy Stevens, Kristina Strand, Lora Stewart, Randi Allfather

The meeting started immediately following a shortened Sunday service. The Chalice stayed lit for this meeting.

- 1. **Meeting Called to Order** at 11:35am by President Loretta Middleton
- 2. **Opening blessing and words** by Rev Linda Simmons
- 3. Quorum of 25+ voting members determined by Clerk Susan Richards
- 4. **Special recognition of Gary Langley** Jack Weinhold spoke eloquently about Gary's many varied contributions to the congregation and the island! Thank you Gary for all you have brought to our Congregation, our Meeting House, and our Island!
- 5. **Approval of minutes of 2022 Annual Meetings** Clerk Susan Richards MOVED and Lora Stewart seconded that we approve the minutes of the 1/30/2022 Annual Congregational Meeting along with the 8/14/2022 Special Congregational Meeting with name correction made by Jim Sulzer in the Parsonage update in the 8/14/2022 meeting (from Andy Scott to Andy Bennett –person who is helping do much of the maintenance work on the Parsonage)

Minutes to both Congregational meetings unanimously approved with name change in Parsonage report....

6. **Constitutional Amendments** – Clerk Susan Richards MOVED and Lora Stewart seconded that we approve the constitutional amendments illustrated and explained in the accompanying document (two-thirds vote required)

Discussion – Steeplejacking – could wording be changed to not including a vote? Emphasis on the process of becoming a member rather than being voted in? Meet and greet committee – Trial period? Extensive – Change the motion so that the President can meet with Prospective members.

Jim Sulzer MOVED and Polly Miller seconded that we remove the phrase "and has been duly invited by vote of Board of Trustees" from Article 4, paragraph 4. Unanimously approved with 1 abstention

Susan Richards MOVED and Val Hall seconded to accept Congregational Meeting approved amendments as amended to:

Article 3 paragraph 1 (add "six to" before the phrase "nine elected members")

Article 4 paragraph 4 (add Board President and "to discuss membership" phrase)

Article 5 last paragraph (add "four to" before the phrase "six persons")

Article 7 paragraph 1 (change quorum from 25 members to 30% of certified members)

Article 10 paragraph 2 (add "the" before the first instance of "Church").

**Final version of amended Article 4 – Membership** – Any person eighteen years of age or older who is in sympathy with the purpose of this Church, has read and accepts the covenant of the Church, has met with the Minister or, in the Minister's extended absence, the Board President, to discuss membership, and has agreed to support the Church to the extent of that person's ability, shall be welcomed to membership on signing the Membership Book. All members are expected to support the Church and to participate in its activities.

Discussion and suggestions in regards to amended Article 4:

- 1. A 'New UU' class with the minister or Board president and several other members of the congregation to discuss membership.
- 2. A one year waiting period between becoming a member and the ability to vote at congregational meetings.

## 7. 2023 Annual Budget

Treasurer Paul Stewart MOVED and Val Hall seconded that we follow the unanimous recommendations of our Finance Committee and our Board of Trustees and approve the 2023 'Unlikely To Exceed' budget on page 4 of the budget document on our website (also on page 43 of our 2022 Annual Report), which is a summary of the details on the pages following."

Discussion - of "the unknown"

Fewer ministers available for congregations in need.

Column AK in Budget - Unlikely to exceed" (Total of non-transition and transition columns) -

This entire budget is not as predictable as in prior years – best scenario..we will have an Interim minister and spend all of this budget. Have included the full cost of a full time business manager without any of the potential income that a position – Questions about minister transitions costs – UUA recommends \$10,000 –

VOTE called for and taken - Motion to accept the 2023 Budget passed unanimously

8. **Officers and Nominating Committee** Carl Borchert, Vice President thanked all outgoing Trustees – Loretta Middleton, Susan Berman, and Kathy Stevens, and SCPF Directors Angus Macleod, Mary Bergman, Marion Roland Conley, and Gary Langley. Thank you all for your service!

- a. Peter Richards moved and Vall Hall seconded the nomination of Paul Stewart as Treasurer – VOTE taken and Paul was unanimously voted in for another 1 year term.
- b. Peter Richards moved and Susan Fernald seconded the nomination of Trustees Carol Benchley, Barbara Elder and Suse Robinson. VOTE taken and all three were unanimously voted in for 3 year terms.
- c. Returning SCPF Directors Christine Sanford -President, Chris Hanson -Treasurer, Polly Miller- Secretary, Bob Middleton, and Susan Hochwald.
- d. Peter Richards moved and Susan Farrell seconded the nomination of Ann Perkins, Peter Richards, and Jim Sulzer to return for another year's term on the Nominating Committee - Voted on and Approved unanimously
- 9. **Celebrating Rev Linda** President Loretta Middleton spoke eloquently in celebration of Rev. Linda's ministry. Thank you, Rev. Linda for everything you have brought to our Congregation and Island Community!
- 10. **Full-time Interim Minister** Carl moved and Paul seconded to Affirm the Board's recommendation to try for a full-time interim minister

Discussion – it will be challenging but we would really like the help and guidance – Interim ministers usually start August 1st – the UUA has a "draft" of congregations that need a minister and ministers needs – the whole Board is working on this – PT interim minister? Not possible for us on Nantucket? What to do with the Parsonage – Interim minister is "pre-fired" – The process is important... send any names of potential ministers (contract/guest speakers) to the Board.

## Transitional Minister Search Task Force Update, Lora Stewart, Trustee

Update to Congregational Meeting August 20, 2023

Task Force Formed 2/25/2023

Lora Stewart, Chair, Randi Allfather, Barbara Elder and Paul Stewart

First meeting: 2/28/2028 – Split up tasks and spent all of March and one week in April preparing our "packet" for the UUA jobs board for an interim minster search. We also crafted a special section for ministers in search on our website.

There is, currently, a very significant shortage of ministers in search for parish ministry so our expectations going into search were low. To our surprise, we received two interim candidates from the west coast whom we interviewed and vetted through their references. We said "yes" to both as they were interesting, had helpful skills and were acceptable to us. However, neither one proved to be a "match". Most years, the UUA Transitions Office holds a second 'round of matches, but, this year, they moved all churches and ministers still in search to the "contract ministers" jobs board where 100 (out of 1000 UU churches in the country) were listed as needing a minister. Since then, we have had

two more candidates express interest themselves. After contacting them it was clear that one was only interested in very part-time and the other was only interested in doing a remote ministry from Tennessee so we decided against going any further with them. Once we were listed on the "contract" jobs board, we also followed up with two non-Unitarian ministers who had expressed interest in us before we began our search for an Interim minister in covenant with the UUA. One had bought a house in France and moved there. The other was more local and our needs were not a good match with his stated goals for his next ministry so those two candidates were eliminated. Rev. Keith Kron from the UUA Transitions Office has been very supportive of us. He sent us one candidate that we liked very much and with whom we worked very hard for much of July to try to agree on a contract. Ultimately, the time she had available to be on the island and the difficulty with arranging twice monthly travel as well as settling on benefits made it clear that it was going to be too difficult to come up with a satisfactory solution for her or us. We learned that we really want someone who can be on island and who can get to know us and help us do some self-discernment in preparation for our next settled minister. It was worth waiting for that minister to be available. We have been exploring some alternatives going forward. Following our recent visit from our last interim minister, David Horst, he presented an idea for starting what he called "The Nantucket Residency"; a program where a series of ministers would come and do some work for our congregation including some Sunday worship services, guiding our self-evaluation and planning for the future and, possibly, also work on a project of their own for several months during their stay. We are intrigued with the idea and will "keep it in our back pocket". In the meantime, the Transitions Office has encouraged another candidate to apply and we have completed an initial, very positive interview. We'll be reporting to the congregation as things unfold. It has been a somewhat frustrating "roller coaster", but the intrepid Task Force is determined to keep moving forward.

#### Financial Update, Paul Stewart, Treasurer BOT

#### Treasurers Report to Congregational Meeting August 20, 2023

We've had quite a roller coaster ride since early August 2022 when our beloved Reverend Linda Simmons announced her resignation.

We approved our first unbalanced budget in my tenure as your Treasurer.

We bid Rev. Linda and Gary a fond farewell.

We hired a full time Business Manager.

Two of our long-term renters ended their terms with us, but two new ones have come to call this their home.

Some congregants have died or resigned or moved away; but some others have come to call this their home.

As Lora reported, we've put a lot of work into searching for a new Interim or Transitional minister to help us thrive and attract a new minister in 2025.

We've done a lot of work on the Parsonage to get it ready for our next minister. Jim will talk more about that.

Through all this year of changes and uncertainty, we have survived and, indeed, thrived.

We have lay-led services which are interesting and attractive.

We have kept going with our usual annual events like:

The yard sale

The 4th of July

The auction

We've had lots of Coffee and Tea and Crafting and Saturday Socials and Friday Fun.

So now to the numbers.

Page 1 is what I report to the Board of Trustees each month. This shows good progress. It also shows us spending some of the money we had saved up in the Parsonage Capital Maintenance Fund.

Page 2 is the nominal and real value of our reserves over time, up to the end of June (our half-year).

From that I can say we're doing fine on our finances.

We'll see more information on all this as 2023 draws to a close and as the 2024 annual budget is developed.

With that, I'll throw the floor open to questions.

#### Lay Led Committee Update, Representative, Susan Richards, President BOT

The Lay Led Committee consists of Kat Robinson Grieder, Val Hall, Susan Berman, Ann Scott, Joanne Polster and myself. This committee is typically charged with creating and leading one service per month, mostly the 4th Sunday. In addition, over the last couple of years we have been filling in services when Rev Linda had health issues that required her taking some time to recover.

Rev Linda's final service before stepping down from her ministry was on February 19th of this year and since then the Lay Led Committee has been meeting regularly, typically twice a month, to work together to create weekly services.

In the 6 months since Rev Linda stepped down plus the two services we led before she stepped down, the Lay Led Committee has created and led 26 services with themes ranging from "The Soul of an Octopus" to "Nantucket's Maritime Traditions" to A "Jazz Service", to a service devoted to Dorothy Day to a recent service featuring the Beatles and much more... If you have an idea and/or would like to join our committee, please feel free to contact one of us...

Special thanks to Kathy Stevens who joined the Lay Led Committee right after Rev Linda left and stayed on temporarily, giving our group a jolt of energy and creativity when we needed it.

I am so proud to be a part of this creative group of hardworking Congregational members. We've really come together to keep our services coming...

For the remaining months of 2023 we are ready to create and lead more services but are also ready to return to a more supportive role should we find a minister!

#### Building and Grounds, Parsonage update - Paul

#### UU General Assembly Report, Kat Robinson Grieder and Jan Ellsworth, Representatives

General Assembly 2023 June 21-25, 2023 Kat and I share our gratitude to Nantucket UUs for electing us as your delegates. A bit about the Unitarian Universalist Association (UUA): UU Website – UUA.org The mission of the UUA, in part, is to equip congregations for health and vitality, to support and train lay and professional leaders, and to advance UU values in the world. The UUA is the central organization of the UU religious movement in the USA, which began in 1961. There is 1000+ UU congregations, all committed to the seven principles as set down in the current bylaws. Each of the UU congregations: Choose to join the UUA and pay a membership fee Are autonomous. Congregational leaders set their own priorities and choose their own ministers. Vote for the leaders of the UUA, who oversee the central staff and resources The UUA The elected president is the chief executive of the UUA and is elected at GA every few years (usually 6) Trains ministers Publishes books and UU World magazine Provides religious education materials and curricula Offers shared services Coordinates social justice activities

The 2023 general assembly was a hybrid meeting – online and in person – and was held in Pittsburg PA

GA uses a democratic process for all voting.

All attendees can participate in workshops, connect with other UUS from across the country, make policy for the UUA and worship together.

Anyone may attend but only delegates can vote

Congregations must certify annually with the UUA before they can send delegates to GA. The number of delegates each congregation may send depends on the number of members you have – Nantucket can send two delegates.

What we voted on at GA 2023:

A new President was elected – Dr Sofia Betancourt – she received 61% of the vote (2320/110) The UUCEF will immediately divest from all fossil fuel companies, including the industries and financial institutions that support fossil fuel projects, and companies that build or own oil fields, companies involved in hydrocarbon exploration and the building of hydrocarbon exploration projects, fossil fuel pipeline builders and owners, and all fossil fuel financiers, including but not limited to all companies that were named in the above

The UUCEF will return an equivalent value of the securities that were invested in fossil fuels as of June 30, 2022, or the total value of securities invested in fossil fuels at the time of the 2023 General Assembly of the UUA, whichever is greater, in the form of reparations to the Indigenous tribes and communities who are the ancestral and continued stewards of this land, Black and Brown communities (prioritizing these communities which are working class) and refugees of prior and ongoing wars fueled by the fossil fuel industry, all parties of which have endured the ongoing violence of racist-capitalist systems which sought to actively destroy them. Article II Revisions: Resources re Article II

https://www.uua.org/uuagovernance/committees/article-ii-study-commission/resources The current UUA bylaws were last revised in 1985 with an update that added the 8th principle in 2017.

The goal of the current planned update is to ensure that UUs are living into a future of great need and ethical, moral, and spiritual crisis.

The revisions began in 2020. The most impactful change will be the elimination of the seven principles. The principles will be replaced by 6 Shared Values and a new UU logo.

The proposed Principles are:

Pluralism: diverse culture, differences and commonalities

Justice: Multicultural, Dismantle Racism and all forms of systemic oppression

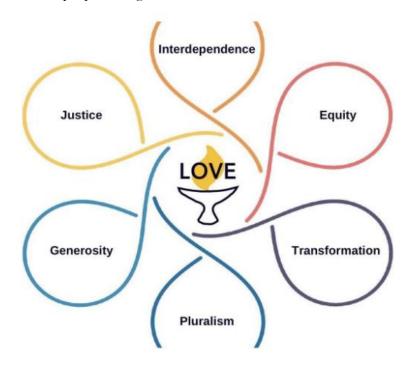
Transformation: Collectively transform and grow

## Minister's Report

Thank you for the opportunity to serve you. I have found you a delight and look forward to our ongoing work.

I arrived at First Unitarian Universalist Nantucket on October 1, 2023. I spent the first several months getting to know you. That has included gathering history, meeting with congregants, pastoral care, and conducting Sunday Services, including music.

Additionally, I have attended as many meetings as I could, both community and church. The meetings have included BOT and Fin Com. I have looked at the budget. I have met with the church staff. I have spoken to almost all of the past ministers of the church. And I have listened to the congregants, their joys, and their worries. I did this over meals and coffee, in homes, and at the parsonage. I have read some of the things on the website.

These efforts have led me to suggest a transition team to the BOT, constructed of congregants not serving on a committee. It informed who should constitute my Committee on Ministry and resulted in my request to the BOT. I meet with the staff regularly.

I am happy to say we have introduced new music. We have a spirituality group meeting for four weeks. Pastoral care visits continue to grow. I was asked to be the keynote for the interfaith committee group. I have been approached but have not committed to joining a healthcare provider group.

I have been mostly impressed with the congregation's commitment to this church's work. I am grateful to have met you all and look forward to our work together.

## President's Report

I dedicate this year's President's Report to Carl Borchert, a great friend to our

UU Congregation, conscientious worker, fierce advocate for green energy, and all-round good guy. Carl took over the presidency of our UU Board at an especially challenging time... He basically started his presidency without a minister which meant that as president he had to take on a huge amount of church responsibilities which he did thoughtfully, thoroughly, and with great respect for all with whom he came into contact. As I write this, about 3 months after his passing, I still can't quite believe I'm not going to see that 6'8" frame amble into Hendrix Hall. There are so many of us who will carry him with love in our memories. Thank you, Carl.



2023 was a year of big changes and challenges for our Congregation. I am going to break the year up into 2-month segments of time to make this year's journey easier to see.

## January/February:

Rev Linda has announced in 2022 that she is stepping down as of February. The Board is hard at work on preparing for her departure from the business of running the church to the farewell party plans. Special focus on: hiring of a full time business manager – (by the end of February Ray Haskell had been offered and accepted the position).

We had our Annual Congregational Meeting on January 22nd via zoom... The 2023 Budget was discussed, voted on and approved. Rev Linda and Gary were recognized and celebrated. Outgoing Board trustees were thanked and incoming trustees were welcomed.

Other items being worked on:

- Prep for Parsonage repair while there is no one living in it. Thanks to Jim Sulzer for leading the coordination of this work and completing it in time for our Transitional Minister Rev Althea Smith to move in at the end of September
- Interim Minister Search Task Force formed with Lora Stewart as Chair lots of work to do in a short period of time!
- Regular updates and contact with Lay Led Committee which begins to plan and lead all services as of the end of February

**March/April**: Linda has left and the Interim Minister Search Task Force is hard at work in the UUA directed process of searching for an Interim minister. Work on the Parsonage has begun and the Lay Led/Worship Committee has started having meetings twice a month to keep up with the work of weekly service planning. We decided on taking the last two weeks in May to prepare for the move back up to the Sanctuary... One week will be a Mother's Day Brunch in the AR and one week will be a Spring Cleaning. Other topics of discussion and work:

- 4th of July event will not focus on fundraising this year but on getting this popular event up and running as we haven't had it in person since 2019
- The BOT voted to appoint Kat Robinson Grieder as a delegate to the General Assembly being held in Pittsburgh. Later we also appointed Jan Ellsworth as a delegate

**May/June**: We voted in a new Covid policy to take effect when the congregation moves up to the Sanctuary on Memorial Day. During our meeting we got the news that our Congregation was not matched with an Interim minister. Later in the month via email we voted to appoint the interim Minister Search Task Force to continue their work as a Transitional Minister Search Task Force with directions to (1) try to hire a Contract or Developmental or other type of full-time minister through the UUA processes and (2) explore productive alternative methods to obtain ministerial leadership for our congregation.

Summer fundraising and event plans are in full swing with Deirdre Duffy taking over as the chair of the Auction committee due to take place in August with Cynthia Cazaby coordinating the 4th of July plans. Barbara Elder has suggested the return of the noon day concerts (which later became a reality, managed by Barbara of course!)

**July/August:** The Board received with regret and appreciation the resignation of two Trustees - Carl Borchert and Kristina Strand.

Kat Robinson Grieder and Jan Ellsworth gave a short report about their experience as delegates attending the UU General Assembly in June. There were about 5,000 total delegates and there was much discussion about the changes to Article II. We agreed that we'd like to hear more about their experiences possibly at a service or in a congregational discussion (which happened during a 2 week service break at the end of October.

Other happenings of note:

August 20th - Summer Congregational Meeting consisted of many important updates from the Minister Search Committee, Treasurer, Lay Led Committee, Building and Grounds Committee, UU General Assembly, and Fundraising. No votes were necessary and there was lots of information shared and discussed. In August, Nantucket UUs were approached by the Warming Place about providing overnight space. Other churches are being approached as well. Much discussion... We all agreed that we would like to help but there is concern about the logistics, the viability of our space and how much space availability we have. Ultimately, we ended up being able to help for one night per week.

In terms of the Transitional minister search -a new candidate, Rev. Althea Smith was interviewed via zoom at the end of the month

**September/October:** The happy news at September's Board meeting came from the Transitional Minister Search Task Force as they proposed that we offer the position of transitional minister from October 1st, 2023 through July 31st, 2024. The Board voted and unanimously approved. Lucky for us Rev Althea accepted our offer and her first service was on October 1st.

Unfortunately, we also had very sad news come our way in October. Carl Borchert unexpectedly passed away on Sunday morning, October 8th. I have dedicated this report to him... He was a part of us... and his dear partner in life, Randi, is still a part of us, reminding us of how important we are to each other.

**November/December**: The last two months of the year were full and busy of course, but we had time to reflect together as we got to know Rev Althea. We enjoyed seasonal and thought-provoking reflections as we celebrated all the holidays and special events of the season.

Finally, the second of my three-year terms on the Board of Trustees ends at this Annual Meeting on January 28, 2024. In total I have been on the Board for 9+ years since I became a Nantucket UU member back in 2012. I came to church wanting to be active in this congregation and I definitely got my wish! Although I am stepping off the Board, I plan on staying active on the Lay Led/Worship Committee, the WE Committee, and the Animal Ministry Committee. While I will miss my friends on the Board and all the camaraderie that comes with being part of a hardworking group of like-minded people, I look forward to devoting more time and energy into those other committees. I trust that the Board will continue on, hardworking as always, adding new trustees bringing their new energy and spirit to invest in this great group.

Thank you to all my fellow Board Trustees... It has been a pleasure and an honor to do the work of the church with you.

Thank you to Lora Stewart who is also stepping off the Board as of the January 28th Annual Meeting. Lora is one of the most dedicated, hardworking members of our Board (and a wide variety of other committees) with whom I have ever worked... a true inspiration!

Thanks also to the 3 ministers with whom I have worked during my time on the Board - Rev David Horst, the Interim Minister who so ably guided us on our journey to being ready for our Settled Minister, Rev Linda Simmons, whom I worked and learned with for almost 10 years, and finally, our current transitional minister, Rev Althea Smith who has hit the ground running as we go forward together on the next steps of our UU journey!

We continue to hear from representatives at the UUA (Unitarian Universalist Association) that there is a nationwide decrease in general membership numbers along with youth numbers not only for UU congregations but for many other organized denominations as well. The Pandemic still has an impact as 2023 is the first year since 2019 that we have completely met in person.

## Hybrid Services:

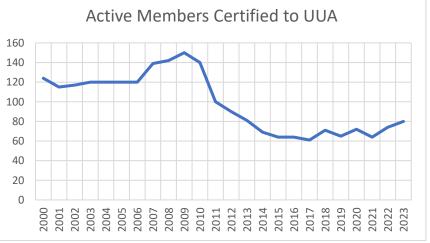
It certainly looks like Hybrid services are here to stay and remote attendance at weekly services has remained steady at 15–20 attendees each week. Except for services like our Animal Blessing and our Christmas Eve service, we are always offering a zoom option now and we are working on ways to optimize the zoom experience and connecting our virtual and in-person congregations.

## Service Attendance:

For the first time since 2019, all services were held in person as well as virtually. We had 4 weeks of events/discussion groups instead of services (no virtual attendance). So, in total, we had 48 services with an average of 30-45 attendance in person and 10-20 virtual attendance. One notable exception to this attendance range was Rev Linda's farewell service which was at 85 attendees in person and 35 virtual attendees.

## Clerk's Committee:

On January 25, 2024, a Clerk's Committee of Barbara Elder, Lora and Paul Stewart, Randi Allfather, Suse Robinson, and Susan and Peter Richards was convened to review our membership list for



the express purpose of reporting our membership numbers to the UUA for UU Congregation Certification. This is done annually in January. Our congregational member numbers have slowly but surely increased in the past 3 years since Covid.

## Music Director's Report

Greetings, and Happy New Year! This time last year, the church was in a very different place. 2023 has been a long year, with heartwarming, uplifting, and exciting moments, as well as uncertain and challenging moments. I was here on 44 of the 48 Sundays we had service in 2023, playing piano, bass, or directing the choir, or all of the above. Jennifer Maxwell subbed for us on Jan 1, 2023, Barbara Elder subbed on April 23, Susan Berman and Ray Saunders led songs for the blessing of the Animals on October 8, and Eddie Wilkin subbed on piano for service on 11/11. We did not have service on 4 Sundays, May 14 and 21, and on October 15 and 22.

In January 2023, we began to prepare for our beloved Reverend Linda Simmon's departure. We gave an all zoom service on January 22 dedicated to Linda, and had guest musicians Chris Hanson and Allison Ritter with us to share some music in her honor. We had a big send off service on Feb 19, Linda's last day at the pulpit, and my goal was to feature as many guest musicians as I could find: Susan and Ray sang "Ready to Sail" by Patrick Alger and Austin Cunningham, they joined Chris Hanson and myself for a rendition of Ashokan Farewell, Paul Connors sang "Accentuate the Positive" and the Meetinghouse Choir sang the Irish traditional, "Parting Glass." It was a beautiful service, and we were all sad to see her go.

Then began the uncertain and challenging task of finding an interim minister. To me as music director, tasked with keeping music alive and vibrant, this meant leaning in and working hard to keep services musically rich, varied, and interesting. We have a core group of choir members, stalwart singers who are constant in their attendance, committed to the craft of music making, and show up with their best voices every Tuesday evening for rehearsal, and Sunday for services. During the spring and summer we saw new faces joining us regularly while some of our winter time members were more busy with summer activities, and when our summer members left in the fall, we had our winter regulars return to more active participation. During 2023 we've also seen more guest musicians than any of my previous years. As mentioned, we had guests during Linda's last months to play her out, but in March, the choir was joined by Avi Chitrit, Michele Whelan, and Rob Dunbar to perform a modern Native American Song called Water Is Life. April was more routine, with choir anthems regularly each week, while I took a week off for school break in April. During May the church had two weeks off, and we reopened in our summer sanctuary on Memorial Day, May 28. Tom Peppard joined us to play taps from the organ loft, and we sang our traditional Memorial Day anthem, Tenting Tonight.

June and July were exciting musical months. Carson Cooman joined us on organ for service on June 4, and on July 2, Ann Scott, Charley Walters, and I collaborated on a Jazz themed service. We were joined by guest pianist Anthony Healy, guest drummer Colin Harrington, and we learned about jazz's long history as a spiritual practice, as well as an American art form. Later that same month, Isaiah Williams played service for us on the Goodrich Organ, and the following Sunday we had another wonderful musically themed service, this time with Susan Richards leading a service based on the 7 principles as illustrated by Beatles songs. We had a lot of fun with this one, and had guest musicians perform and collaborate - Chris Hanson sang "Dear Prudence," Susan and Ray sang "Yellow Submarine," I sang "Fixing A Hole," Bob Middleton sang "In My Life," and then choir and everybody, all together now, sang "All You Need Is Love."

I should mention here, that during July I achieved a personal musical milestone. Some might be aware that I started piano late - at age 26, after earning a Bachelors degree in Jazz Bass Performance. Now, at age 37, I've been studying and practicing piano for 11 years, and for the last 7 of those years, I have been working with a Toronto based piano coach. This year, he suggested I "sit for an exam," through a Canadian organization called the Royal Conservatory of Music. It's a rigorous curriculum with 10 levels from beginner through concert repertory, and on July 28 I sat for my level 7 practical piano exams. This included preparing a 20 minute set of challenging piano music to perform for a jury, answering theory and ear training questions, as well as performing technical etudes and exercises. I passed with a final grade of 92 out of 100, or First Class Honors with Distinction. This was a major milestone for me, and although I didn't make an announcement in service, I consider this achievement to be a vital part of my growth as music director. The work required to prepare for the test has made the work required to perform for services that much easier, and I'm now able to tackle more technically demanding choir music, and perform more varied and interesting repertoire during Sunday Services with more ease and confidence. I'm continually grateful for the opportunity this congregation gives me to hone my craft, sharpen my skills, and I will continue to strive to grow my skills and knowledge to provide interesting music for this congregation.

In August, Carson Cooman came back and played two dates for us - August 13 and 20. September opened up with another music centered service, this time with a Labor Day Theme. We had guest jazz pianist Jake Vohs, Amanda Torchia on vocals, and Avi Chitrit on percussion, and we sang Work Song by Nat Adderly, the Ballad of John Henry, and performed an arrangement of mine featuring transcriptions of old work songs.

On September 24, after a long period of waiting, uncertainty, and hopefulness, we welcomed our newly hired contract minister Althea Smith to our sanctuary for a visit. She began as minister the following week, but this week she came with her partner Melissa as a guest. Avi and Chris played with us that day. The choir sang Woyaya, and we performed an original song of Avi's called, "I Love You Because I Love You." On October 1, Rev Althea took the pulpit, and we had a new minister with us.

The choir took the month of October off, so Althea's first two Sundays were sung by Jessica Sanseverino on October 1, and Susan and Ray on October 8, for the Blessing of the Animals. The church took October 15 and 22 off from regular service.

The month of November was more or less quiet, but one service highlight was the service for Indigenous People's day, and Day of Mourning. It was a wonderful service led by Rev Althea, and we had Amanda Torchia leading songs, including a beautiful song in the Ojibwe language called "We Remember You," or "Gimikwenimigo."

The last month of 2023, December, was a busy month. In music world, I decided to pull out a few stops and reach out to guests from the wider island music community. On December 3, we had a full band and 9 person choir, and we welcomed the Christmas season with a trio version of Vince Guaraldi's "Christmas Is Coming" from the Charlie Brown Christmas soundtrack. On December 17, I invited more choir guests, and we sang our traditional midwinter anthem "Solstice Song." On Christmas Eve, December 24, Kat Grieder and I led a "story and carols" service - Kat and Suse Robinson read "The Legend of the Christmas Rose," we sang carols, and had guest singers Cynthia Csabay, Amanda Torchia, and Kip Buccino. On the final Sunday of the year, New Years Eve December 31, we celebrated Kwanzaa. We had guests Phaedra Plank, Jessica Sanseverino, and Chris Hanson, and sang "We Are…" by Ysaye M Barnwell, and a Swahili folk blessing called Bwana Awabariki.

All this to say, 2023 has been busy! I look forward to continuing to provide quality music for the congregation, and am excited to learn what 2024 has to bring.

## Noonday Concert Report

We were fortunate to hold the Noonday Concert Series once again in our historic and beautiful sanctuary. In the summer of 2023, the Noonday Concerts restarted following a two year hiatus due to the pandemic. The last concert season was in the summer of 2020 when Nigel Goss produced a virtual series. 2020.

There were a total of seven concerts beginning on July 13 and held every Thursday at noon after the bell tolls 52 times. The Noonday Concerts began to feature our historic Goodrich organ and have grown to include other performances as well. Ten musicians performed half hour concerts, some of which were in very hot and humid temperatures. Our audiences averaged around 12 - 20 people per week. We started with a balance of \$322 and ended the series with \$748. Donations (suggested only) are taken at the door and musicians are paid a small stipend.

# **Buildings and Grounds Committee**

The B&G Committee oversees regular maintenance on the Meeting House and the Parsonage. The South Church Preservation Fund handles much of the capital (major) maintenance on the Meeting House. A Parsonage Capital Maintenance Committee (which overlaps somewhat with B&G) oversees major work on our parsonage.

Carl Borchert was the organizer of B&G for a good while; we miss him! Since his passing, Meeting House annual maintenance projects have been done as needed but without the welcome organization he brought to the work.

#### Parsonage Capital Maintenance

Our lovely old Parsonage has long been in need of work. And our Parsonage Capital Maintenance Committee (Nancy Mack and Jim Sulzer [*co-chairs*], Paul Stewart, Rob Dunbar, Carl Borchert) has been hard at work this past year.

In preparation for the expected arrival of a new minister in early fall of 2023, the Parsonage Committee—at the direction of the Board of Trustees—oversaw extensive repairs and renovation. These were possible both because the Parsonage was unoccupied beginning in March 2023 and because of the funds gathered over the years in the Parsonage Capital Maintenance Fund.

Here's a summary of the work that was completed this past year:

#### Windows and downspouts

-repaired all windows
-replaced trim and windowsills as needed
-redid questionable downspouts, cleaned gutters
-purchased and installed new storm windows for all windows

#### Painting

-repaired and repainted ceilings on first floor, repaired office bookshelves, repainted entire kitchen, repainted first floor bathroom, other interior ceilings -repainted entire exterior, and both interior and exterior of window sashes

#### Handyman work

-weatherstripping, replaced basement door, replaced vanity 2<sup>nd</sup> floor, replaced vent/light/heater 1<sup>st</sup> floor, replaced walls 1<sup>st</sup> floor bathroom, electric repair

#### Plumbing

-repaired leak in first floor bathroom shower valve and pipe -repaired leak under vanity in second floor bathroom -replaced defective toilet on second floor

#### Still left to be done:

-Replace bad sills on office side of house and Main St side of house -dig trench by office side of house for drainage

**Money \$\$** spent to date: about \$65,000, all from the Parsonage Capital Maintenance Fund.

Since the beginning of Covid, the **Growing Connections Between Friends and Members Committee** has supported and encouraged an ever-expanding sense of community within and beyond our Meeting House. The committee has supported both old, established groups and encouraged new groups to form. Sometimes these groups have been virtual and sometimes it has been possible to meet in person. It should be noted that one of our older congregants was often the "star of the game", while the rest of us struggled to get even half correct. Happily, more recently, we have been able to meet in person and have even added fairly regular potlucks before the games begin. Most of us like to eat and we are all hoping the virtual "Cooking Group" makes a return appearance in 2024.

The Saturday Morning Craft Group has been meeting since well before Covid and it is certainly one of the "stars" of this committee. This group understands the many components that go into nurturing a thriving community. This weekly group has given rise to many friendships within the Meeting House and has encouraged people from the wider community to join in. Each year, members of this group support the Caring Team by creating "comfort shawls" for distribution by the Team to those facing a challenge. They provide a place to develop friendships within and outside of our congregation. There were also 2 weeks in May and 2 weeks in October when we had other special happenings instead of formal services – A Mother's Day Brunch, A Spring Cleaning of the Sanctuary in May and two UU themed discussions in October. All in all, our Lay Led Committee led/coordinated 40 weeks of services and weekly events!

# Interim Minister Search Task Force

The Reverend Linda Simmons was our settled minister for nearly ten years. In August, 2022, Rev. Linda informed the congregation of her intent to leave and, in February 2023, she said goodbye to the parishioners to start her "next chapter" as a psychotherapist. Her Goodbye Party with the congregation was on February 18, 2023. Shortly thereafter, at a special meeting of the Board of Trustees on February 25<sup>,</sup> 2023, the Ministerial Search Task Force was appointed. The members of this Task Force were: Lora Stewart, Barbara Elder, Randi Allfather and Paul Stewart.

At the Task Force's first meeting on February 28, 2023, Lora was unanimously voted to be Chair and the group divided the work to be done. This group worked very well together and spent all of March completing our "Packet" for the UUA Jobs Board and accomplishing other tasks involved in searching for an Interim Minister using the UUA's process.

We soon learned that, unlike in times past, there was a dearth of minister candidates this year. After the warning from our regional UUA representative, we weren't expecting any interest in our small congregation 30 miles out to sea. To our surprise, we attracted two candidates and spent the month of May vetting the two that had expressed interest; reading their materials and checking references as well as interviewing them over Zoom. We told the Transitions Office that we would accept either as a "match". Unfortunately, they were both from the west coast and elected to stay in that part of the country near their extended families.

In most years, the Transitions Office has conducted a second round of search. In 2023, they decided, instead, to refer all churches still in search and all ministers who had not found a match to the pool of around 100 unmatched churches vying for matches with "Contract Ministers". The bad news was that this was even more competitive than the search for strictly Interim ministers. The silver lining was that a contract minister can come to a mutual agreement with a church to provide whatever service that church needs. In our case, we worked out an Agreement with Rev. Althea to do interim work for us.

During the four months of June, July, August and September, the intrepid Task Force (now titled the "Contract/Transitional/Interim Minister Search Task Force") considered two non-UU ministers who contacted us independently, several more UU ministers who wished to do most of their work remotely (from as far away as Tennessee) or fit all of their hours into two weekends a month. Several others had promising skills but little time to offer. What a "roller coaster"!

In early September, Rev. Dr. Althea Smith appeared on our radar. In her we saw someone who had a rich background of skills including a divinity degree, a nursing degree and a doctorate in psychology. Her community ministry and activism would stretch our congregation's imagination to try new things. We called her references, interviewed her and had her come, with her partner, to introduce them to the island. By the end of September, we had come to an agreement with her about our interim needs and she came to start her interim work with us on October 1<sup>st</sup>.

We have spread the news of the UUA Animal Ministry and encouraged our two UUA delegates to vote to support the change of wording in our UU Principles when they attended the UU General Assembly in June.

#### Immigrant Resource Center

In 2017 we accepted the Immigration Resource Center under the umbrella of our 7th Principle Project as an additional component of our ongoing social justice commitment.

The IRC originally offered legal advice and support to immigrants in need.

When COVID hit in 2020, the IRC reduced the advice it offered and started to receive and disburse funds to Islanders in need who were not receiving other forms of support.

In late 2023, as COVID funding was winding down and efforts on The Warming Place were revving up, the IRC decided to pause its operations until need (and leadership) revives.

The IRC's separate \$3,719 bank account, shown in row 5 of the chart on page 40, will be retained for a while to see if the IRC revives. If the IRC stays inactive for another couple of years, we will need to determine if that money must be returned to grantors or can be merged into our Social Action Fund, to be available for similar efforts in the future.

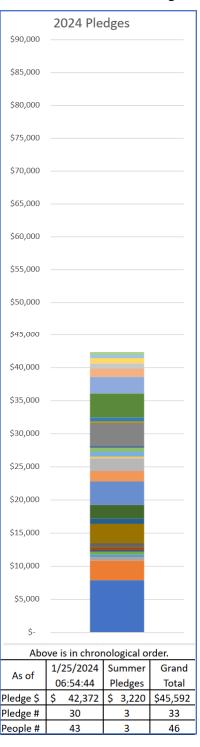
On October 14 the Pledge Campaign mailed 90 pledge requests to members and friends, from which we ultimately expect about 62 pledges totaling about \$83K.

# Annual Report of the Treasurer and Finance Committee

The Finance Committee advises the Board of Trustees in two main areas, our annual budget and our investments, and provides an annual report to the congregation. This is that annual report.

Your Treasurer's main duty, according to our congregation's Constitution (available in our Congregational Handbook on our website), is:

"Article 10: section 3. It shall be the duty of the treasurer to hold in custody all funds of the Church; to keep an account of all receipts and expenditures; to pay such bills as may be approved by the Board of Trustees [and/or the congregation]; and to render at the annual meeting, and at such other meetings as may be required, a full financial statement of the Church."

This document is that "full financial statement of the Church" to annual meeting.

If you want just a general idea of our finances, here are some summaries:

**One sentence summary**: In 2023, a period of many changes, generous support, lowering inflation, and positive stock market growth, our congregational finances are in fine shape with a positive net worth of nearly \$2.2Million, although our annual budget was unbalanced for the first time in 10 years.

**Slightly longer summary**: As above, plus: The following table shows all our bank and investment account balances over several years. Row 16 shows the effect of the market on our Unrestricted Reserves investments. More details on our Unrestricted Reserves are on page 41. Row 21 is our 'financial net worth' (we have no debts).

#### **Unrestricted Reserves**

Referring again to the "All Financial Assets at Institutions" table on page 40, we can see that the bulk of our financial assets are in our Unrestricted Reserves (cell AR16 is 90% of the total in cell AR21). Our Unrestricted Reserves Policy is "to maintain the real value of our Unrestricted Reserves in perpetuity, while using as much as possible, as steadily as reasonably possible, to support our congregation's activities".

Here is a history of our Unrestricted Reserves from 2005 to now, with inflation adjustments. From this we can see that our policy (instituted in 2014) has been working over the years:

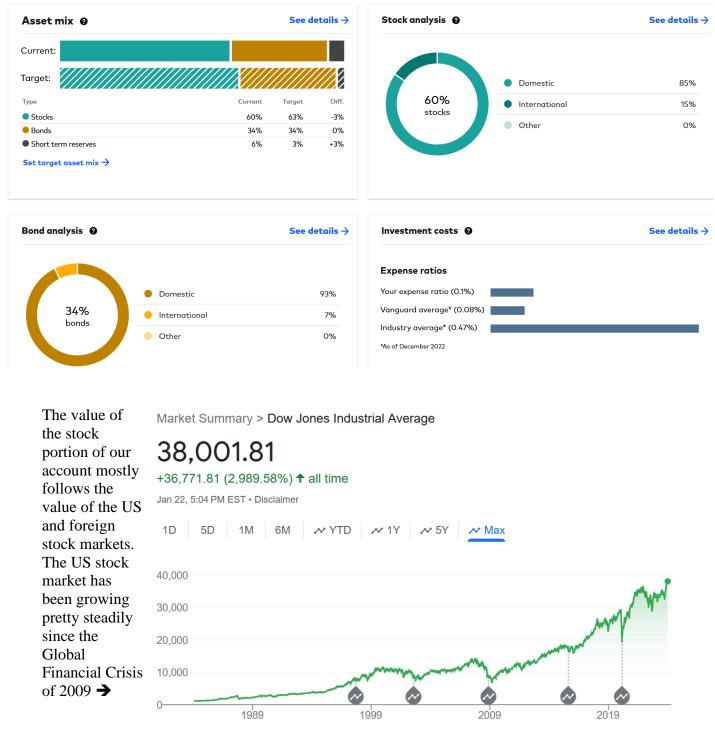
American Tower Corp (ATC) mistakenly paid us \$118K too much in 2019 and 2020, and then agreed to consider those as prepayments of the money they should have paid us through ~2028. They have stopped paying us until that prepayment is exhausted. We're steadily metering those prepayments into our annual budget in the years when they should have come to us.

The "ATC" prepayment balance was \$81,799 as of the end of 2023 (not included above).

#### Investments

From early 2015 to early 2023 the majority of our Unrestricted Reserves were invested at Vanguard, and a smaller amount at the UU Common Endowment Fund (UUCEF). In late 2022 our Finance Committee and Board recommended that we simplify our affairs by merging the money from the UUCEF into our larger investment account at Vanguard. That merging was completed in January, 2023.

Our Vanguard account is now 100% of our Unrestricted Reserves, our main investments:



#### **Restricted Funds**

Our Restricted Funds are those that have been set aside and designated for a particular purpose. The purpose of the Funds that are "R"estricted can be changed by the congregation or Board. Funds that are marked "RD" are Restricted by Donor and the permission of all donors must be obtained before a Fund's purpose can be changed.

The money of these Funds is located in our two main checking accounts (rows 10 and 12 in the All Financial Assets at Institutions table on page 40). The IRC Restricted Fund is in a separate bank account (row 5 on page 40). The Organ Maintenance Fund has two parts, a modest working balance in this table plus a separate investment account at TIAA (row 18 on page 40).

Note we spent plenty of money from the Parsonage Capital Maintenance Fund on our parsonage doing necessary maintenance (downspouts, window and door repairs, new storm windows, interior and exterior painting, plumbing, etc.) while it stood vacant from March to September.

The Sabbatical Provision Fund is money the congregation set aside to provide for a Sabbatical Minister if Rev. Linda took the sabbatical leave she was entitled to. The UUA recommends that this can be repurposed to help with the search for or relocation of another minister, but our congregation has the right to redesignate it for any purpose.

We are still working on finalizing details of the 'Actuals' for the 2023 Annual Budget. Since the larger transactions (e.g., payroll is 2/3rds of our expenses, and are exactly accounted for by our payroll processor) are well-known, it is only certain small amounts that require further refinement. Our deficit for 2023 will be  $62,000 \pm 3,000$ .

The recommended 2024 annual budget is discussed, summarized, and detailed on the following pages.

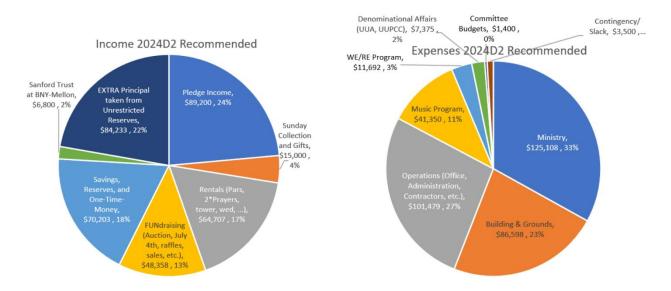

# 2024 Recommended Budget

This budget material has been posted on our website since January 9 and we held well-attended 'Congregational Conversations' on January 21 (in person) and January 22 by Zoom to discuss our finances and budget.

Ray Haskell started as our full time Business Manager on February 16, 2023. Our goal was to relieve the administrative and business work of our congregation from our Minister and our Treasurer, and that goal has been successfully achieved. Thank you, Ray, for your good work for us!

The recommended 2024 budget includes raises of 4% for all employees; that raise will apply to our minister in August.



After the budget was approved by the Board on December 13 and posted on our website on January 9, we received notice that our Church Mutual insurance premiums for 2024-2025 will be fractionally less than what is projected; that's good news but not significant enough to amend the recommended budget now.

On the following pages are the 2023 Annual Budget document as posted on our website and as unanimously recommended by our Finance Committee and Board of Trustees.

#### From the Finance Committee's report to the December 13, 2023, Board meeting:

**Finance Committee** 

**1**. General Purpose: The FC is responsible for making recommendations to the Board on all matters relating to Church finances, but it is not a canvas, pledge, or fundraising committee.

2. Specific Responsibilities: The responsibilities of the FC include but are not limited to the following:

a) Reviewing the Church's goals and needs as defined by the Board and articulating these in terms of short- and long-term financial strategies

b) The Finance Committee shall develop the Church's annual budget in conjunction with the various departments and committees, within the context of the actual financial realities and long term goals, and present a budget to the Board of Trustees for approval by December 15, and then to the congregation two weeks prior to the annual meeting.

c) Monitoring the Church's assets, liabilities, income and expenses and making periodic (at least annual) reports to the Board and the congregation

d) Advising the Board on investment strategies and long-term needs for raising funds. Arranging for an annual audit or review of the Church's financial records

from our Congregational Handbook on our website

Our 2023 Finance Committee consists of Randi Allfather, Bob Middleton, President Susan Richards, Rev. Althea Smith (non-voting), Treasurer Paul Stewart, Chair, and Jim Sulzer.

Pursuant to the above, and particularly 2.b), the FinCom held a Zoom meeting from Noon to 2:30PM on November 3 to discuss our finances and our 2024 budget recommendation in detail. Also attending that meeting were Trustees Carol, Suse, and Lora.

Then the FinCom zoomed on December 5 from Noon to 1PM to discuss the 2024 budget and agree on their recommendation to the Board (so it could be distributed to the Trustees before our Board meeting on December 13).

The FinCom was unanimous in its recommendation of the 2024 budget in this document to the Board. However, no one would say it is a satisfactory or sustainable model for the long term.

Paul explained that we are in a time of transition between called ministers and in our administration. We bid adieu to Rev. Linda (and Gary) at the end of February, 2023. We had a difficult time attracting an interim minister to help us in this transition, and we spent a lot of effort this year in that effort. Rev. Althea started after the usual Interim Minister start. We are mainly trying to keep things moving forward, including several unusual expenses (for example, we must budget \$10-\$15K of relocation costs for each of the Interim minister and the called minister). We'll have to work with our called minister to adjust our future expenses to our income.

At its December 13 meeting, after discussion, the Board voted unanimously to "(1) accept the Finance Committee's recommendation for the 2024 annual budget in column AO, (2) accept responsibility for the various FUNdraisers (especially the July 4<sup>th</sup> plan), and (3) distribute this budget to the congregation in early January so it can be the topic of one or more congregational discussions before Annual Meeting."

The annual budget recommended unanimously by both the Finance Committee and the Board of Trustees:

Paul's comments: You'll immediately note that this budget is significantly out of balance, only brought back into apparent balance by the red "EXTRA Principal taken from the Unrestricted Reserves". Unfortunately, that "EXTRA" is poorly named, we had a significantly unbalanced budget in 2023 and took no extra principal out of our Unrestricted Reserves (we instead didn't spend as much as was budgeted and we drew down our bank accounts somewhat. In fact, our Unrestricted Reserves and our 'financial net worth' grew in 2023; more on that on the last page of this document).

This budget provides for a full time Minister and a full time Business Manager and the same hours for all our other employees for all of 2024.

This budget gives all employees a 4% raise (although that raise takes effect starting on August 1 for our Minister).

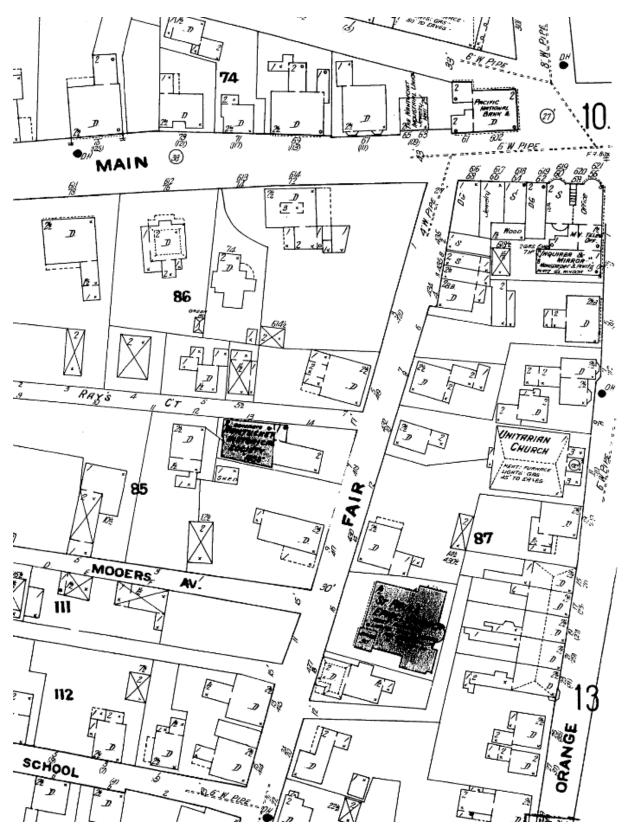
